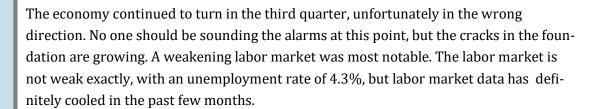
# Third Quarter 2025 Financial Review









Of course, labor market data is a month behind as the payroll and jobless claims releases have been postponed because of the government shutdown. As of this writing, the shutdown is in its fourth week and has no end in sight. It's quite possible this will break its previous long for a shutdown, which was 35 days. No awards will be handed out for that prize, instead furloughed workers that aren't getting paid should lead to a drag on spending, or at the very least create upward pressure on household debt levels, which continue to climb to worrisome levels. The shutdown could also lead to mass layoffs of federal employees and some federal workers retiring early, which will only worsen the employment picture.

The Federal Reserve cut the federal funds rate by 25 bps at its September FOMC meeting, its first cut since 2024. They noted that the "downside risks to employment have risen", acknowledging a weakening labor market. So for now, the Fed is shifting the focus to the 'employment' side of their dual mandate. Inflation isn't going away quietly, however, and as of September it's running at 3% Y-O-Y. How the Fed balances the weakening labor market with above-target inflation will be fascinating over the coming months. Markets are currently pricing in 25 bps cuts at both the October and December meetings, which seems reasonable. If inflation is sticky in 2026, then this debate could turn political as Powell is replaced by a presidential appointee who will likely lean towards cutting rates.

The good news is our balance sheet continues to be well positioned to thrive in any interest rate environment as we can adjust quickly to any changes in interest rates. We continue to focus on operating in a safe and sound manner while providing our members with solutions to meet their needs.

## **Income Statement Highlights**

- The year-to-date Income from investments was \$12,524,415 which is down -22.12% compared to last year when it was \$16,082,140. This decrease is due to 3 interest rate decreases totaling 1% in the latter part of 2024.
- Dividends paid to member credit unions of \$8,410,847 were also down -29.53% compared to last September's year-to-date total of \$11,934,918, due again to falling interest rates.
- CUSO income for the first nine months of this year is \$38,134 which compares favorably to last year's \$1,963.
- The Fee Income we derive from managing off-balance sheet amounts has increased. Fee Income for the first half of the year shows a 13.9% increase compared to last year.
- Overall, Total Operating Expenses were 2.02% higher so far this year than the same timeframe in 2024. Much of this increase is in Professional Fees expenses.



# Third Quarter 2025 Financial Review







### **Balance Sheet Highlights**

- Total Assets as of September 30, 2025, are \$348 million which is -18.89% lower than in 2024. Due to the volatility in the size of our balance sheet we rely on a 12 month Moving Daily Average Net Assets (MDANA) to reflect balance sheet trends more accurately. MDANA of \$376.7 million on September 30 is 0.27% higher than the balance of \$375.7 million at 09/30/2024.
- Net Fixed Assets on September 30 is 6.53% lower than it was one year ago. Various asset purchases in 2025 have largely offset ongoing depreciation accounting for the rather small decrease in net fixed assets. Purchases include investment in new network equipment and other technology related purchases. Currently all our office furniture and fixtures are fully depreciated while our technology assets' book value is at 65.24% of cost.
- Management borrowed \$30 million overnight on September 30, 2025, for strategic liquidity purposes. There was no borrowing on September 30, 2024.
- We again returned a portion of PCC to our members in September totaling \$3.37 million. In 2024 Tricorp received approval from NCUA to periodically return unneeded PCC to members at a rate of 20% of the original balance per year. This approval was only given for 2024 and 2025, as long as specific capital benchmarks and operating results were maintained. Tricorp's board is currently evaluating whether to re-apply to NCUA for additional distributions.
- Undivided Earnings are \$3,687,275 or 8.54% higher at 09/30/2025 than the balance one year ago. This represents our unaudited net income for 12 months ending September 30.
- The Unrealized Loss on our Available for Sale securities as of September 30, of (\$1,122,845) has improved slightly since September 2024 when it was (\$1,145,700).

### **Capital and Other Ratios Highlights**

- Our Retained Earnings ratio shows an increase in the past 12 months from 11.49% in September 2024 to 12.44% currently. The Capital Ratio is at 14.67% compared to 14.65% last year. While we have been very profitable, the return of PCC in September has offset that income causing our capital ratio to remain flat.
- The base level NEV ratio as of 09-30-2025 is 15.95% with a regulatory minimum requirement of 2.00%. In a scenario that projects a rate increase of 300 basis points (3.0%) our NEV changes by -5.82% to 15.16%. The maximum regulatory decrease based on our level of authority is -20.00%.
- Tricorp currently has Tier 1 and Total Risk Based Capital ratios of 118.57%. These ratios far exceed the regulatory minimum of 8%. The Weighted Average Life (WAL) of our balance sheet on September 30 is 1.26 years, which is below the regulatory maximum of 2 years.
